I acknowledge that Con Edison, its company partners, New York agencies, and authorities will use this information and my attestation to determine whether a rebate will be issued. I have read and agree to the terms and conditions for Customers participating in the Program included here.

By my signature below, I represent to Con Edison that the Invoice information reflected in the foregoing table is true, accurate, and complete to the best of my knowledge; particularly, that the Quantities, Measure(s), Material Cost, Labor Cost, and Total Cost information are true, accurate, and complete, and so reflect all relevant information, including charges for labor, materials, equipment, and services performed to complete the installation; and, further, I agree that I must provide to Con Edison upon request original invoices in support of all or any part of the Final Invoice information provided. I hereby affirm that all information regarding the completed installation of New York State Clean Heat Program-eligible equipment described above is accurate and true to the best of my knowledge, and that Con Edison has provided or will provide a Customer Incentive, through the Incentive Option agreed upon.

Customer agrees that Con Edison may utilize and provide customer information including customer name, account number, electric and/or gas consumption data, and electric and/or gas energy savings to its third-party evaluation contractor for program evaluation purposes. The evaluation contractor will keep customer information confidential. With advance notice to the customer, following completion of the project and in order to provide Con Edison with an opportunity to review the operation of the eligible measures for program evaluation purposes related to the determination of final project savings and incentives, the customer agrees to cooperate with any effort by Con Edison or its contractors and subcontractors, to make or to have made follow-up visits to customer facilities, and the customer shall provide building energy system data, supporting documentation, and otherwise cooperate fully in support of this effort. Con Edison or an authorized entity on behalf of Con Edison may also conduct assessments (including field visits), audits, or inquiry on work performed under the Program in order to maintain the quality standards sought by Con Edison's programs, and the Customer agrees to cooperate fully in connection therewith.

Customer information may also be provided to the New York State Public Service Commission. Any customer information provided to the New York State Public Service Commission will be aggregated with information about other customers and not personally identifiable.

All non-public sales and customer information transmitted to Con Edison during the application for participation in the Program and during participation in the Program is recognized as sensitive information and handled confidentially. This information, in addition to information about individual program performance, will be shared only with Con Edison and Con Edison's subsidiaries and/or parent companies, and their regulators, and will not be made available publicly; provided, however, that Con Edison and Con Edison's subsidiaries and/or parent companies may retain and use statistical, aggregated information, including for research, product development, and strategic planning, provided that neither the Participating Contractor nor the customer is identified individually.

In addition, Con Edison may provide notice to the customer to conduct certain additional inspections and "Evaluations, Measurement and Verification" (EM&V) activity, including post-installation heat pump metering, to ensure the accurate determination of savings, and also to support quality installations and to ensure that the customer complies with the rules of the Program.
